NTCA Pushes Mapping Updates to Better Reflect State of Competition

In a [filing with the FCC](#), NTCA highlighted the commission's inability to obtain an accurate depiction of the state of competition in communications markets without improvements to the Broadband Data Collection (BDC) and data the agency collects with respect to the availability of voice services.

The filing comes as the commission prepares its [Communications Marketplace Report](#), a mandated effort to detail the state of competition across the industry.

NTCA shared concerns about the commission's BDC work, noting that providers can still make far-reaching claims of coverage without showing any meaningful subscription. Without changes to provide an accurate and more reliable baseline of data on broadband availability that can then be used to make informed decisions, [NTCA wrote](#), assessing the state of competition in the marketplace would be challenging.

NTCA, RLEC Stakeholders Raise Practical and Legal Concerns with FCC NG911 Proposal

NTCA and a group of rural local exchange carriers (RLECs) this week continued to seek changes to draft FCC rules seeking to promote a transition to Next Generation 911 (NG911) in a [meeting with staff to Commissioner Anna Gomez](#).

The discussions come as part of NTCA's response to a [FCC Notice of Proposed Rulemaking](#) meant to advance the transition to NG911. NTCA has long supported this transition as rural consumers will benefit from the transmission of text, photos, videos and data as part of 911 calls, yet the association also has sought to ensure that the costs of this are not disproportionately placed upon rural consumers. Previously, the association and industry partners [proposed alternative cost allocation rules](#) to avoid such increases and met with representatives from the offices of FCC Chairwoman [Jessica Rosenworcel](#) and Commissioners [Nathan Simington](#) and [Geoffrey Starks](#), as well as the [FCC's Public Safety Bureau](#).

First at Bat: Secure Internet Routing

Right on the heels of the FCC adopting the **Open Internet Order** in April, in which the commission concluded the agency has authority to regulate broadband services, today the FCC

adopted a **Notice of Proposed Rulemaking** that would require all broadband providers to prepare and maintain a plan for implementing Border Gateway Protocol for their Internet Protocol addresses.

Need to Know

NTCA **filed comments** with the FCC regarding steps the agency can take to foster consumer access to independent programming. NTCA noted that marketplace obstacles such as the use of most favored nation and unreasonable alternative distribution method provisions may hinder independent programmers from reaching consumers.

The SRC Showcase Awards are annual awards presented to SRC providers to recognize their extraordinary achievements in promoting rural broadband networks and their broadband-enabled applications in rural communities. **Applications** for the 2024 awards are due next Friday, June 14.

The FCC approved a **Notice of Proposed Rulemaking** to seek comment on changes to the rules for letters of credit required for recipients of high-cost support authorized through a competitive process.

The FCC's Public Safety and Homeland Security Bureau will conduct a **voluntary Disaster Information Reporting System (DIRS) exercise** from June 10-12, 2024, to ensure communications providers can access and file reports in the DIRS system and help familiarize new employees with the DIRS reporting process.
