NTCA Urges Enhancements to FCC Mapping, Broadband Data Collection Processes

In meetings with staff to FCC Commissioners **Anna Gomez** and **Nathan Simington**, NTCA highlighted several issues for the commission to consider as part of its **mapping and Broadband Data Collection (BDC) updates**.

Those **recommendations**, which follow the release of the **fourth iteration** of the National Broadband Map, include

strengthening reporting verification efforts, enabling greater use of performance and subscription data to inform challenges and otherwise to update several BDC challenge codes, closing loopholes that allow providers to avoid submitting data to back up coverage claims, updating procedures to overcome successful or conceded challenges through reasserted claims of availability, considering changes to reporting standards to reflect proven technological capabilities in lieu of advertising claims and reviewing the use of BDC data in making better-informed decisions that affect broadband funding and policies.

Leading the Way: A Discussion on Mapping, Universal Service and BEAD

In the **latest edition** of Policy Talk, NTCA CEO Shirley Bloomfield and Executive Vice President Mike Romano discussed the association's ongoing advocacy efforts to correct data in the FCC's National Broadband Map, protect and sustain the Universal Service Fund and improve implementation plans for the Broadband Equity, Access, and Deployment (BEAD) program.

The two discussed NTCA's **recent advocacy efforts** to bring about enhancements to the commission's mapping and BDC processes, as well as the latest updates in the fight for universal service.

NTCA members are united in their efforts to achieve and sustain universal service. Previously, **Ben Foster**, president and CEO of Twin Valley Communications (Miltonvale, Kan.), and **Stephen Milner**, CEO of Planters Telephone Cooperative (Newington, Ga.), shared the need for programs that aim to build networks for today and tomorrow and the importance of taking a longer view when making policies.

This week, **Cassidy Hjelmstad**, CEO and general manager of SRT Communications, Inc. (Minot, N.D.), and **Roger Nishi**, vice president of industry relations at Waitsfield and Champlain Valley Telecom (Waitsfield, Vt.), talked about the importance of accurate data on the FCC's National Broadband Map.

The U.S. Supreme Court **denied** a request to hear an appeal of decisions by the U.S. Court of Appeals for the Sixth and Eleventh Circuits, both of which upheld the constitutionality of the Universal Service Fund.

NTCA joined three industry associations in **filing a letter** proposing a way to identify costs and Enhanced Alternative

Connet America Cost Model support levels for newly established locations in the FCC's Broadband Serviceable Location Fabric.

Jared Owen, cybersecurity analyst at Highline Services, LLC (West Point, Ga.), was **appointed** to the FCC Communications Security, Reliability, and Interoperability Council to represent NTCA. The council provides recommendations on ways the commission can help to ensure security, reliability and interoperability of communications systems.


